Dear Friends,

When we launched this Strategic Planning process just three months into my tenure at the Civic Federation, our objective was to develop a vision for the Federation's future — a future that builds on our legacy of excellence, imagines the greater impact we can achieve, and leverages our unique competencies and standing in the community.

Given that the world has changed dramatically since the last strategic plan in 2012, it was vital that this process prioritize a generationally refreshed vision rather than more technically oriented implementation. The final product presented here reflects six months of collaborative work with a wide range of past and present stakeholders.

The Civic Federation's core mission – to analyze and promote sensible fiscal and governance policies and transparent practices in the pursuit of better delivery of government services – remains unchanged. However, this strategic plan provides a roadmap to deepen and expand that work. It charts a course toward increased public engagement and education, deeper subject-matter work, and stronger organizational governance and transparency.

At its heart, this strategic plan presents a unified vision of The Civic Federation's vital role and reflects the community's aspirations for our future. It lays out exciting possibilities for where we might go while giving us the flexibility to adapt to a rapidly evolving world.

The need for the Civic Federation's authoritative, nonpartisan voice is at an all-time high. We have an incredible opportunity to meet that moment while also expanding our reach to a broader audience. I am deeply grateful to join you on this journey.



Who We Are: Our Focus

As we enter an era of strategic evolution, what remains constant is our steadfast civic leadership and commitment to provide objective research and analysis on government finance issues for the Chicago region and State of Illinois.

We will continue to produce fiscal analysis and provide recommendations on the four largest State and local government entities—State of Illinois, City of Chicago, Cook County and Chicago Public Schools. To focus on the financial challenges of these major governments and respond more nimbly to current events and policy changes, we will produce more digestible, forward-looking reports and continue to adjust our research agenda to be able to proactively respond to current events, engage government leaders and policymakers, and focus on implementation of the Federation's recommendations.

We will reinvigorate robust conversations and collaborations with partner organizations, philanthropic institutions, and members to ensure that our research remains both useful and relevant. This may take the shape of new projects, joint efforts, or deeper research into existing core areas of study.

Finally, we will expand the ways in which we communicate and disseminate our research to ensure that all Chicagoans and Illinoisans are equipped with the knowledge they need to advocate for themselves.



What We Learned

The Civic Federation should double-down on what we do best, while modernizing how we do it and to whom and how we communicate it.

Stakeholder voices were loud and clear.

The Civic Federation is known for the strength of our research, our value as a nonpartisan policy watchdog, and our ability to connect civic, community, and business leaders. Looking ahead, we will collectively reflect on the need to build on our foundation, deepening and broadening our engagement activities, diversifying our funding strategy, and modernizing our approach to governance through welldefined Board and volunteer roles.

Unfailingly, stakeholders communicated the value of the Civic Federation as a contributor to civil society, while gently urging the Civic Federation to strengthen its governance, finances, and engagement for continued success in our next chapter.

Process

These insights come via multipronged stakeholder engagement, including a constituent survey, interviews and collaborative workshops with Board members and other stakeholders, a staff workshop, and an off-site retreat facilitated by our partners at Crowe LLP.

Throughout summer 2024, we reflected on and identified themes, conflicts, and opportunities from these listening sessions and engagement activities, seeking to first understand and then hone our strategic vision. What We Learned

Several themes emerged from stakeholder insights, ranging from what the Civic Federation does well to what stakeholders seek to modernize – engagement, governance, and sustainable funding.

Members and participants overwhelmingly value the Civic Federation as a chance to meet and network with others of similar interests. There is a call for more events and opportunities to connect. When asked about organizational strengths, stakeholders resoundingly value the Civic Federation as an independent, nonpartisan voice conducting relevant policy analysis.





Many question the efficacy of current governance. There are missed opportunities to connect Board talents with organizational needs, and the large Board is functionally challenging.

The current funding model is both inextricably linked with the governance structure and relies on membership and a primary annual event. There is an opportunity to develop a diversified funding strategy to drive sustainable growth.

The Civic Federation would not be the powerhouse it is today without the support and guidance of its members over the last 130 years. Building on this momentum, we pledge to establish a Board structure that meets the evolving needs of our organization and the community.

This includes enhancing our transparency through clearly communicated roles, responsibilities, and expectations with members.

We will also initiate structured onboarding and orientation for members, accelerating engagement so we connect their talents with opportunities.

- Removing the link between governance role and membership structure
- Significantly revising the bylaws to create a new governance structure to support oversight, financial management, and fundraising.
- Establishing a formal member onboarding process.
- Regularly revising our committees and working groups to ensure that we are meeting the needs of the moment.
- Building membership to reflect the diversity of the region.

Where We Go from Here



We will explore sustainable funding strategies that expand and diversify our revenue streams.

The Civic Federation's funding approach has worked over the years but needs a refresh. We have experienced a plateau in funding and recognize that we are overly reliant on membership fees and special event revenue.

- Expanding and clarifying membership tiers and benefits.
- Deepening ongoing and building new relationships to support multi-year commitments.
- Engaging with funders to support specific projects and general operations.
- Exploring opportunities for earned revenue, including options to license data use, certain specialized research, and new ticketed programming.

This strategic plan is only a starting point. We recognize that substantial efforts are needed to uphold our mission and the new vision and values presented in this report. We will lean on our staff, Board, and members to keep forward momentum for the following key initiatives:




